ORDINANCE NO. 2-02

AN ORDINANCE OF THE BOROUGH OF EAST BANGOR, NORTHAMPTON COUNTY, PENNSYLVANIA, AUTHORIZING THE JOINT INCORPORATION OF THE BANGOR AREA SCHOOL DISTRICT REGIONAL ECONOMIC DEVELOPMENT AUTHORITY, AND RATIFYING THE EXECUTION AND DELIVERY OF INTERMUNICIPAL AGREEMENT CONCERNING FORMATION OF THE AFORESAID AUTHORITY.

WHEREAS, the Borough of East Bangor is geographically located within the boundaries of the Bangor Area School District; and

WHEREAS, East Bangor Borough Council believes that economical development in the boundaries of the Bangor Area School District, regardless of its location, will help relieve the tax burden on all the citizens of the School District, including those in the Borough of East Bangor; and

WHEREAS, East Bangor Borough Council believes that a Regional ~ Economic Development Authority would provide the greatest opportunity to promote economic development within the School District's boundaries.

BE IT ORDAINED AND ENACTED, AND IT IS HEREBY ORDAINED

AND ENACTED by the Council of the Borough of East Bangor, County of

Northampton and Commonwealth of Pennsylvania, as follows:

SECTION 1: The Intermunicipal Agreement, attached as "Exhibit A" hereto, is approved. The proper Borough officials are authorized to execute and deliver the Agreement, or substantially similar Agreement, to the other parties to the Agreement, for execution.

SECTION 2: The Borough of East Bangor shall join in the incorporation of the Bangor Area School District Regional Economic Development Authority. The Articles of Incorporation attached to the Intermunicipal Agreement are approved. The proper Borough officers are authorized to execute and deliver such Articles of Incorporation, or substantially similar Articles, to the Secretary of the Commonwealth.

SECTION 3: East Bangor Borough Council may appoint, by motion, the Borough's representative member to the Authority's Board.

SECTION 4: That any Ordinance, or part of any Ordinance, conflicting with this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.

SECTION 5: This Ordinance shall be and remain in full force and effect from and after the date of its enactment.
